May 8, 2013 Board Meeting Minutes

Chairman Steve Mader opened the meeting with the Pledge of Allegiance. Supervisors Rhonda Helgeson and Tom Jacobs were present. Clerk Lois Meinking and Treasurer Mary Leuck were present.

The clerk read the minutes of the April 10, 2013 meeting. Tom Jacobs made a motion to approve the minutes and Rhonda Helgeson seconded the motion. The motion passed. The clerk read the minutes of the annual meeting April 16, 2013. Rhonda Helgeson made a motion to approve the minutes. Tom Jacobs seconded the motion. Motion passed. CTH OA was discussed. Steve Mader made a motion to approve renaming the dead end road, Casa de Sol requested by Jean Klos. Rhonda Helgeson seconded the motion. Motion passed.

Steve Mader made a motion to approve an updated and established ordinance to include an annual application and license for operators of mobile home parks. Tom Jacobs seconded the motion. The motion passed. Ordinance 2013-2 will be published by State Statute. The discussion on fire pits, wood stoves, and wood burning in mobile home parks was postponed.

The loader tire discussion was postponed.

Chairman Mader read the list of road repairs for the crew. Sweeping will be scheduled in St. Joseph. Road repair costs will be received in the next 30 days.

The Clements private road agreement was discussed with Al Radtke and residents. The concern for emergency vehicle access and action taken were discussed. Al reported providing 10 loads of gravel May 1.

Speed Limit discussion was postponed for Strittmater Road.
