Regular Board Meeting
Minutes October 12, 2016

Chairman Mader opened the meeting with the Pledge of Allegiance at 7:00 p.m. at the Town Hall N1800 Town Hall Rd., La Crosse, WI 54601. Supervisors Tom Jacobs and Brandon Wright were present. Treasurer Mary Leuck was present. Clerk Lois Meinking was present. The clerk read the minutes of the Sept 14, 2016 meeting. Motion was made to approve the minutes as read Jacobs/Wright. Motion passed 3-0. The treasurer presented the financial report for September. Motion to approve report Wright/Jacobs. Motion passed 3-0.

Superintendent Troy Gunderson and School Board Presidents Clements provided information about the referendum questions on the ballot November 8.

Lions Club requested liquor license for Nov. 4 fundraiser. Motion to approve Wright/Jacobs. Motion passed 3-0.

The chairman provided the recycling report. Winter hours start Tuesdays in November 1:00-4:00 p.m. Tires and appliances need to be hauled in November. Park shelter will be winterized.

Road report was given by Chairman Mader. Disaster Report and FEMA meeting was discussed from September 21 rainstorm: Schieche, East Hills, Kreibich Coulee, and Betz.

Mike Miller was present for Evelyn Miller requesting easement released back to 40 feet. Butch Miller will pay publication and legal fees. Motion was made to pass a resolution to move the easement Jacobs/Wright. Motion passed unanimously 3-0.

Motion to schedule Town planning Commission meeting Mader/Jacobs. Motion passed 3-0. Motion made to provide street privilege permit Mader/Jacobs. Motion passed unanimously.

Kenneth Malzacher N2090 Malzacher Rd. was present to request additional 50' X 90' building and fence. Motion made and seconded to accept change in Zoning after the fact for additional building with no change in other conditions Mader/Jacobs. Motion passed unanimously 3-0.

The legal advice of WTA on covenants was discussed.

Motion was made to increase the tax levy by resolution \$9,263 or 2.26% to include \$90,000 for road repairs Mader/Wright. Motion passed unanimously.
