Regular Meeting Minutes
March 14, 2018

Chairman Mader opened the meeting with the Pledge of Allegiance at N1800 Town Hall Rd. La Crosse, WI 54601. Supervisors Tom Jacobs and Andy Neubauer were present. Treasurer Mary Leuck was present. Clerk Lois Meinking was present. Motion to approve minutes Jacobs/Neubauer. Motion passed 3-0. Treasurer gave the financial report for February. Motion Jacobs/Neubauer to approve financial report. Motion passed 3-0.

Election results of 160 voters were given: County Treasurer Republican Pamela K. Hollnagel 55; Democratic Chad Hawkins 13; Amy L. Twitchell 77; Justice of Supreme Court Rebecca Dallet 63; Michael Screnock 59; Tim Burns 28; Westby Area School Board Seat #3 Denise Grass 2; Craig Johnson 2; David Eggen 2; West Salem School District Referendum 76 Yes; 23 No. FEMA updates were given.

Kreibich Coulee Rd. bridge inspection requires emergency work. County inspection graded it as serious. Bartsch Rd. damage Feb. 26th when a farmer was logging. Will discuss in future meeting.

Discussed a letter to send to 30-40 landowners who farm or rent land out because there has been damage to town roads. Motion Jacobs/Neubauer to approve letter be sent out with modification of amount from flood damages. Motion passed 3-0.

Septic Inspection letter from La Crosse County was read. Not a problem if the fee remains the same as is currently.

Clements Road discussion about potentially having township take over road. Mathy doesn't think we are going to get a 22 ft. road. Suggested an estimate from St. Joseph's Construction.
